CO-RCM 'A' & CO-RCM 'B' REPORT

Hello Area

We attended last region where we only had 8 area's in attendance. Due to only having 8 out of 15 areas, the regional body established simple majority to conduct business. We were unable to proceed with any more business during 2nd roll call since we were down to 7 area's in attendance leaving us with no quorum.

Since we were lacking area's the chair decided not to have us read area reports, and instead discuss the pressing issue of guiding the MRLCNA sub-committee to make a decision on how to move forward with MRCLA. We did this because one of the regional representatives from another area had to leave, which would have made it hard to allow any voting to occur.

This is from the Regional minutes:

New Business #1 – MARLCNA; Direction with the deposit \$.

Discussed shortly after 2:00 PM due to losing quorum. The Marriot is requesting a decision by July 19th meeting (August per contract) regarding MARLCNA '21. If "Force Majeure" or a force of nature happens, they can roll it over to 2022. However, per our contract, we have requirements and requests for this event that Marriot must upheld as well. If the Marriot cancels, we get our deposit back. If we cancel before August's deadline, we receive 40% or \$4,000.00 back. If we cancel after August, the full 100% will be forfeited. Pocono Mtn RCM, Kathleen M. requests a straw-poll be taken. 2nd by Beehive RCM Alt., Allan C. Chair, Timmy F. allows this. York Area RCM George S. appeals. Discussion continued and various members of the regional body gave their opinion. The Regional chair will be in contact with the MARLCNA committee and their meeting on the 19th. We may need to schedule an emergency regional body meeting. No decision made by RCM's today.
